Rev. Following the introductions, two of the class (Greg Bergquist and Ofa Ha'unga briefly testified to their experience so far.

Disaffiliation Discussion

The Board of Trustees report reviewed additions to the Trust Clause of <u>paragraph 2553</u> which expires on 12/31/23 including paying a share of the Boy Scout of American settlement portion, any unpaid bills, tithe, pastor compensation and 20% of the fair market value. If sold, the conference has the first right of refusal. (see <u>report</u>)

Under the adopted agreement, Cal-Nevada churches would be required to pay (1) any unpaid tithe for the past year (2) an additional year of tithe (3) its share of unfunded pension obligations (4) its share of the Annual Conference's settlement amount in the Boy Scouts of America bankruptcy case (5) any unpaid property insurance due the Conference's unit insurance program (6) any unpaid clergy compensation and benefits and (7) 20% of the fair market value of its property. The Conference would retain a right of first refusal on the property, giving it the right to repurchase the property at 20% of its fair market value if the church desires to sell the property in the 7 years after disaffiliation. Point #7 about the 20% property value payment generated A LOT of discussion! Annual conferences across the nation have different amounts from 0% to 100%. Cal-Nevada chose 20%.

Item 23 about Disaffiliating Churches in Cal-Nevada brought by Rev. Richard Thompson of First UMC Bakersfield and Rev. Dr. Kah-Jin Jeffrey Kuan of Claremont School of Theology was deemed out of order by Bishop Dyck except for the opening paragraph and paragraph #4. The item said the provisions would be only for those churches going into independent status when the intent of Paragraph 2553 (passed by Special General Conference 2019) was for churches wanting to become part of the Global Methodist Church denomination and Paragraph 2553 states, "the terms and conditions for that disaffiliation shall be established by the board of trustees of the applicable annual conference." Item 23 stated that the Annual Conference could not add any more terms to the disaffiliation agreement than what was in the item. However, the item 23 had not included some terms established by the Conference Board of Trustees, especially the payment of 20% the fair market value of the property. Paragraph 2553 gives the authority to the Conference Board of Trustees for the terms, not the Annual Conference session.

The conference voted to refer the recommendation to the Board of Trustees. Bishop Dyck prayed over the session noting, "When we tug, push and pull, we see more clearly."

Budget

Chair of Conference Finance and Administration (CFA) Rev. Kristin Stoneking of Epworth UMC, Berkeley reported that our annual conference is one out of eight conferences who gave full apportionments last year achieving 100% giving over the last 5 years. California-Nevada conference has the highest *unrestricted* assets in the Western Jurisdiction. Note that this does NOT include real estate which would be *restricted* assets. Below are pictures of the more interesting slides in the presentation.



The picture on the right shows that we have the finances to take care of whatever ministries we want. It's just a matter of how it's prioritized.



The picture on the left shows we've been using the money from church closures to fund new church starts. The picture on the right shows that most churches have been doing the tithe and as local church income changes, so does the funding for the connectional ministries.



This slide was shown when Rev. Stoneking talked about the need to diversify our revenue sources. <u>Budget (Item 1)</u> was presented and was approved on Sunday afternoon. Select the <u>Recommendations link</u> to download the PDF and view the Budget recommendation on pages 2 to 11.

Legislative Coordinator for the Annual Conference Session, Rev. Elizabeth Cademartori of Novato UMC, moved for the approval of the Consent Calendar. The Consent Calendar had two items: 1) Creation of a Climate Justice Ministries taskforce; and 2) resolution on the demolition of olive trees in Wadi Foquin (West Bank Palestinian village located in the Bethlehem District). It was approved. Item 22 as amended was approved (select the link to download the Word docx file). Item 22 is a resolution on invitations to establish relationships with our Jewish neighbors. Rev. Tikiko Lesuma member of the CORE team and pastor of Hope UMC in Sacramento moved Item 8 on a Conference-wide Shared Facility Policy be approved. It was approved.

Retiree videos included Rev. Craig Brown, Rev. Dan Sturdivant, Rev. Kathi McShane, and Rev. Jim Crawford.

Lunch events included the <u>Bystander Intervention</u> led by Ossama Kamel CAIR Sacramento Valley/Central California Community Organizing and Engagement Manager explaining values of safety, steps to intervene, and how to deal with the attacker's anger. The event was sponsored by the <u>Committee on Advocacy and Justice</u>, <u>Commission on Religion and Race</u> and the <u>Commission on Christian Unity and Interfaith Relations</u>.

The California-Nevada Conference <u>Committee on Reconciliation</u> (CCOR) sponsored "What Will the #UMC Look Like Tomorrow" featuring guest speakers Rev. Dr. Rebekah Miles from Texas, Rev. Dr. Jeffrey Kuan, Dr. Randall Miller and Rev. Dr. Izzy Alvaran with special testimony by Rev. Graner, the first out gay clergy ordained in the South Central and Southeastern Jurisdictions of the UMC.
